Subject: Call-up notice of additional fund for water supply from HMWSSB  
CGEWHO's Hyderabad-III Housing Scheme.

Sir/Madam,

This is for information of all the beneficiaries of Hyderabad Ph-III housing scheme that after protracted interactions at the M/o Housing & Urban Poverty Alleviation, Govt. of India and other official(s) of CGEWHO as well as continuous support of the resident beneficiaries, namely, Dr T S Reddy, PMC member, CGEWHO has been able to get the approval towards bulk 'Water Supply' and 'Estimate of execution of the works' of Rs.1.68 crores on 12/11/2014 issued by Hyderabad Metropolitan Water Supply and Sewerage Board (HMWSSB). HMWSSB had sanctioned water connection for 190 KLD of drinking water through the existing pipe line of Rural Water Supply (RWS).

2. A detailed discussion was held in the O/o of the CEO in the presence of Dr T S Reddy, Professor V V S N Rao and Dr J Nataraju who are the beneficiaries of Hyderabad Ph-III housing scheme. Since, the expenditure was **NOT** catered for in the final costing of the project, CGEWHO is now forwarding a demand of **Rs.44,000/= (Rupees forty four thousand only)** per flat/dwelling unit for provisioning of the bulk water supply. HMWSSB has considered equal quantity of water for each flat/dwelling unit, irrespective of its Super Built-up Area (SBA).

3. In order to deposit the above amount with HMWSSB, all beneficiaries are requested to remit an amount of **Rs.44,000/= (Rupees forty four thousand only)** {Rs.1.68 crore/380 (No of flat)} irrespective of type of flat/dwelling unit through **Demand Draft** in favour of 'CGEWHO A/c 0267101018816 Canara Bank, New Delhi' payable at New Delhi due on **17/12/2014** so that further onward necessary action can be initiated by CGEWHO Project office thereafter.

4. The copies of the 'Sanction Order' & 'Estimate of Works' as provided by HMWSSB are uploaded in the website of CGEWHO i.e. [www.cgewho.in](http://www.cgewho.in) for information in general along with this demand letter
