It is brought to your notice that CGEWHO is, a **welfare** organization, playing role of a **facilitator** of housing and all the CGEWHO's projects are conceptualized and executed on 'self-financing' and 'No profit no loss' basis unlike projects of the Private Builders. In case, you do not make payment as per para-2 above, then it will be presumed that you are NOT INTERESTED in the allotment of flat/dwelling unit and **you will be dealt as per above rules as quoted in para-2 above**. The organization is incurring the cost of interest due to delay and default from your side.
- 4. There are certain beneficiaries who have filed complain(s) before Consumers Forum(s) against the organization challenging recasted cost of dwelling units or on other reasons whatsoever.
