




1. Representative member of M/o Law & Justice in Project Monitoring Committee (PMC) has not attended the meeting.
2. The General Body meeting of allottees ,beneficiaries started at 10.30hrs. CEO, CGEWHO & Chairman Project Monitoring Committee detailed Sh. Angna Ram Dy. Secy. M/o HUPA to work as Presiding Officer for the conduct of election of the five members from the allottees of project for Project Monitoring Committee (PMC) Mohali Ph-II Project of CGEWHO with the consent of the allottees and contestants present in the General Body Meeting.
3. The procedure of election was explained to the allottees / beneficiaries present.
