## **NOTICE**

## Election for Formation of Apartment Owners Association (Adhoc) to be held on 15.10.2023 at 10 AM at Kendriya Vihar - Greater Noida (Phase I) Housing Scheme

Sh Akhil Saxena, Consultant (Housing Division) will be the Election Observer and Counting Observer to ensure free and fair election.

Following are the modalities/ procedure to be adopted while conducting the election:

- 1. On verification of Identity, only eligible voter will be allowed to enter into the Election Hall. Voters are requested to bring at least one photo Identity Card for verification.
- 2. Physical/in person voting process is scheduled from 10 AM to 1 PM on 15.10.2023 (for those who have not cast their through postal ballot).
- 3. The voting will not be conducted for unopposed 14 contestants as displayed on CGEWHO's website.
- 4. Lunch Break will be from 1.30 PM to 2.00 PM. One box of refreshment will be distributed to each eligible voter.
- 5. After the physical voting is concluded, the total count of physical and postal ballot paper will be done in the presence of all contestants from 2 pm onwards.
- 6. The validity of postal as well as physical ballot paper will be examined only by the committee members of CGEWHO under the supervision of Election Observer and Counting Observer.
  - i) Basis of invalid ballot paper of eligible voter:
    - a. If the eligible voter has voted for multiple contestants / contestants of different tower.
    - b. Duplicacy of ballot paper, i.e. by post and physical with a vote to multiple contestants.
    - c. Without signature on ballot paper.
  - ii) Only one valid vote will be counted, which is either by post or by physical voting if both the ballot papers voted to only one contestant.
- 7. After verification of validity of ballots as detailed above, address / name mentioned in the Ballot paper shall be folded in a manner to hide the identity of voter in order to maintain the secrecy and the Ballot paper will be arranged block wise for counting of votes casted.
- 8. Contestants will be called to witness the counting and counter signature on the result sheet for their respective blocks.
- 9. After declaration of result of tower representative(s), all the elected members will have to take necessary action for further election / selection of office bearer among themselves. Thereafter, name of elected / selected office bearers duly signed by all the elected tower representatives, shall be submitted to the Election Observer cum Counting Observer for further submission to Director (Fin).
- 10. Formal meeting to be held between the elected office bearers/members and Director (Fin) of CGEWHO.
- 11. The list of elected office bearers / members will be published accordingly.
