Date: 02.07.2025

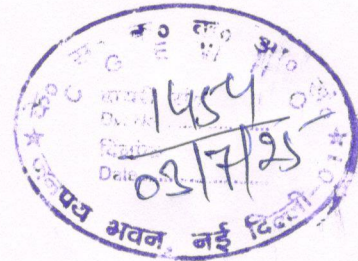
Time: 1800 hrs
