## All the beneficiaries of Greater Noida (Phase-I) Project.

## Subject: Fresh Election for Re-Constitution of AOA – KVGN Phase-I and Registration thereof.

Sir,

This has reference to our letter No. A-407/6 dated 30.10.2024 regarding the dissolution of the Adhoc AOA of CGEWHO's Greater Noida Phase-I project. The Adhoc AOA, constituted on 15.10.2023, could not fulfill its key objectives, particularly the registration of the association and takeover of common areas.

- 2. Consequently, fresh elections were conducted on 01.12.2024 to reconstitute the Adhoc AOA with the primary objective of achieving registration and facilitating the handing over of common areas. While the newly elected body have taken over and managing the common areas, however, the registration process have been hampered due to objections raised by few Executive Members.
- 3. In an effort to resolve the matter, Adhoc AOA convened an Annual General Body Meeting on 20.04.2025, during which, the majority of members was in agreement for immediate registration of the AOA without any preconditions. The minutes of this meeting is enclosed herewith. Subsequently, the Registrar of Societies rejected the AOA's request for registration on 08.05.2025.
- 4. As evident, CGEWHO has made earnest efforts to facilitate the registration of AOA by conducting elections twice. Unfortunately, due to internal disagreements among Adhoc Committee members, the process have been derailed from time and again.
- 5. It is pertinent to mention here that AOA funds are nearing exhaustion and to ensure the continuation of essential services and maintenance, CGEWHO has decided to conduct **fresh elections** to form an AOA (Adhoc) comprising **10 Board Members**. These board members will be elected to exclusively perform the following activities:-
- a. Frame by-laws in accordance with local regulations & registration of AOA with the Competent Authority.
- b. Open a bank account for the AOA
- c. Establish a system for collection of common area(s) maintenance charges.
- d. Convene a General Body Meeting to constitute a regular Executive Committee.
- 6. You are requested to forward your nomination for the board of members by **29th May 2025**. The detailed election process alongwith the schedule of election and nomination form are being uploaded to website <a href="https://www.cgewho.nic.in">www.cgewho.nic.in</a>.

Payment to agency will be made by CGEWHO from AOA fund after certification of bills from GM Project, Gr. Noida.
