Minutes/ Proceedings of the Meeting of Owners of KVGN held on 20.04.2025

A meeting of owners of Kendriya Vihar, Greater Noida (**KVGN**) was held on 20.04.2025 to discuss the issue of registration of AOA. The meeting notice was issued on 10.12.2025 and circulated through on various WhatsApp groups of KVGN. A gentle reminder was also sent by e-mail on 16.04.2025 to all the owners along with specific agenda item, i.e. "Way ahead for registration of AOA and necessary resolution(s) for achieving the purpose".

The meeting was held as scheduled on 20.04.2025 at 11:00 AM (attendance sheet attached).

At the outset, the President, Sh. Narendra Sharma, AoA (Ad hoc) welcomed all the participants especially those who came from distances. He briefed the participants about why the special meeting on specific agenda was organized. He narrated the house that they have already applied for Registration of AoA in Dy. Registrar office, but the process has been on hold since the 5 Executive Members namely (i) Sh. Rahul Deo, Jt. Secy, (ii) Sh. P. K. Sharma, Treasurer, (iii) Sh. B. M. Saxena, Member, (iv) Sh. A. P. Srivastava, Member, and (v) Sh. Nitin Khandelwal, Member were reluctant to submit the relevant documents. Even these five members have since submitted their reply in Dy. Registrar office, objecting to the registration of AOA. Thus, on the one hand, the four Office Bearers/ Members have honored the mandate given, the ones named above are creating hurdles/ obstacles in the way of registration, which is against the mandate given to them.

After deliberations, it emerged that majority of owners (103 in number) present were in favor of immediate registration without attaching any pre-conditions. Following resolution was passed.

- 1. We hereby extend unconditional support to registration of AOA, KVGN.
- 2. We also hereby authorize the President, ad hoc Management Committee of AOA, KVGN to take all necessary steps for registration of AOA, KVGN, including removal from the ad hoc Management Committee of those Office Bearers(s)/ Members creating hurdles in the way of registration.

The signed resolution is enclosed as **Annexure-I** (total 7 sheets). In order to save time of those coming from distant places, the signatures were obtained parallelly on sheets.

It was also decided that the minutes would be shared with CGEWHO for appropriate further action at their end.

It was, however, observed that there were a few owners, including three from the Management Committee (as named above) who refused to sign the attendance sheet. Rather some of them tried to disrupt the meeting proceedings by creating ruckus and commotion. The commotion was so high that the police team deployed to oversee the proceedings was compelled to intervene by entering the meeting place and somehow the meeting was managed to be concluded.

The meeting ended with the vote of thanks to chair.
